

# Site Visit to Daya Bay Nuclear Power Station on 5 November 2011



#### **Facts about Daya Bay Nuclear Power Station**

- ➤ H.K. Nuclear Investment Co. Ltd. (HKNIC) founded in 1983, is an investor in the Guangdong Nuclear Power Joint Venture Co. Ltd. which owns the Guangdong Daya Bay Nuclear Power Station.
- The power station is managed and operated by a sister Company of HKNIC, the Daya Bay Nuclear Power Operations & Management Co. Ltd. (DNMC). Both HKNIC and DNMC are subsidiaries of CLP Holdings (CLP).
- > The power station has an installed capacity of 1,968 MW and since beginning commercial operation in 1994, has been generating over 10 billion kilowatt-hours of electricity a year.
- > Days Bay comprises two identical 984 MW pressurized water reactor type electricity generating units.
